**NATIONAL PROSECUTING AUTHORITY ACT, 1998 (ACT NO. 32 OF 1998): AMENDMENT
OF REGULATIONS RELATING TO INVESTIGATING DIRECTORATE AGAINST
CORRUPTION**

The Minister of Justice and Constitutional Development has, under section 40, read with sections 19D(3) and 22A(4), of the National Prosecuting Authority Act, 1998 (Act No. 32 of 1998), made the regulations in the Schedule.

SCHEDULE

Definitions

1. In this Schedule, "Regulations" means the regulations published under Government Notice No. 5137 of 19 August 2024.

Insertion of regulation 2A in Regulations

2. The following regulation is hereby inserted in the Regulations after regulation 2:

"Form and manner of complaints to retired judge

2A. (1) A complaint in terms of section 22A(4) of the Act shall be made in writing in the form set out in Annexure 1.

(2) A complaint made in terms of section 22A(4) of the Act may be lodged by electronic mail, post or be delivered at the office of the retired judge.

(3) The form in Annexure 1 and information setting out the manner in which a complaint must be lodged, the name and all relevant contact particulars of the retired judge appointed in terms of section 22A(4) of the Act, shall be placed on the website of the prosecuting authority and be made available to all offices of the prosecuting authority.

(4) Complaints may also be lodged at any office of the prosecuting authority, which shall ensure that the complaint is submitted to the retired judge without any delay.

(5) The retired judge may require from any complainant to submit any allegations made to him or her in the form of an affidavit.”.

Amendment of regulation 3 of Regulations

3. The following regulation is hereby substituted for regulation 3 of the Regulations:

"Short title

4. These regulations are called Regulations relating to Investigating Directorate against Corruption, 2024.”.
